WESTERN CAPE GAMBLING AND RACING REGULATIONS (FEES AND  
COSTS), 2016: DRAFT AMENDMENT, 2022**

The Provincial Minister of Finance, in terms of section 81 of the Western Cape Gambling and Racing Act, 1996 (Act 4 of 1996), intends to make the regulations set out in the Schedule.

**SCHEDULE****Definition**

1. In these regulations “the Regulations” means the Western Cape Gambling and Racing Regulations (Fees and Costs), 2016, published under Provincial Notice 97/2016 dated 31 March 2016 and amended by Provincial Notices 81/2017 (dated 24 March 2017), 45/2018 (dated 26 March 2018), 36/2019 (dated 26 March 2019), 28/2020 (dated 25 March 2020) and 37/2021 (dated 9 April 2021).
